



Advancing Feminist Principles in the Asia-Pacific through International Policy A Study

Terms of Reference for Authors

Background

Feminist perspectives in international policy have gained significant momentum over the past decade as part of a broader global movement for gender equality. Feminist international relations theory (IR) critiques traditional power structures that disproportionally benefit men and advocates for intersectional approaches that empower women, marginalized communities, and diverse voices in global decision-making, offering frameworks to better understand and dismantle the hierarchies embedded in international politics, development, economics and geopolitics. However, while feminist principles are gaining recognition for their transformative potential, their application in regional contexts – in this instance Asia – remains underexplored. While countries like Canada, Chile, Germany and Sweden for example have adopted feminist foreign and development policies, there is still a need to deepen evidence-based research and examine how and if these principles can be applied in diverse regional contexts.

The rise of feminist foreign policies (FFP) has not been without its challenges and criticisms. Contextually, the adoption of FFP has been met with backlash, even within some of the very countries that have championed it. This resistance can stem from various sources, including conservative political factions, nationalist sentiments, and concerns about the perceived prioritisation of gender issues over other foreign policy objectives.

Furthermore, there is a critical discourse surrounding FFP globally, including among feminists. Some feminist scholars and activists raise concerns about the potential for FFP to be performative, lacking genuine commitment or resources for implementation. Criticisms, especially among political elites in Asia, also include debates about the definition and scope of FFP, the risk of Western-centric approaches overlooking diverse local contexts, and the potential for FFP to be used as a tool for advancing other geopolitical agendas. Navigating these sensitivities and ensuring that feminist principles are adapted and contextualized to resonate within the region's unique socio-political landscapes is crucial.

Against this background, The FES Gender Justice Competence Centre Asia Pacific together with The United Nations Research Institute for Social Development (UNRISD) calls for author(s) to examine how feminist principles can be applied within Asia-Pacific's' diverse political, social and economic contexts. The study will explore case studies from a range of Asia-Pacific countries. Through engage with local stakeholders, such as policymakers, women's rights organisations and community leaders, the project will identify challenges and opportunities for embedding feminist

principles into international policies across the region. The findings of the study will contribute to broader policy discussions on gender equality and feminist approaches in international relations, aiming to advance progressive discourses, while acknowledging and addressing the existing hesitations and critiques within the region.

Objectives of the study

The study aims to contribute to the body of knowledge on analysing international policies from a feminist perspective. It should offer grounded, context-specific, and evidence-based insights and aim to inform policymaking, generate actionable insights, raise awareness, and advance feminist principles within Asia's international policy frameworks. In addition, the study should feed input for dialogue among the policymakers, practitioners, and civil society actors, contributing to policy discussions on gender equality and feminist approaches to international relations while being mindful of the regional specificities and sensitivities surrounding the adoption and framing of these principles.

Scope of work and thematic focus

Author(s) are expected to:

- Analyse the principles, successes, and challenges of existing feminist perspective in international policy
- Examine the intersections of feminist principles with Asia-Pacific's geopolitical realities, such as trade, development, economic justice, climate action, peace and security and regional integration
- Evaluate opportunities and barriers to implementing feminist principles in international policy in specific Asia-Pacific countries
- Identify localises strategies and best practices in feminist policymaking
- Exploration of entry points for feminist principles within national and/or regional policymaking processes
- Offer actionable, practical and context-specific recommendations for embedding feminist principles into international policy, development and governance frameworks

Authors are expected to incorporate:

- Intersectional, decolonial, feminist perspectives
- Regional policy trends and dynamics
- Engagement with stakeholders in consultation with FES and UNRISD
- Critical reflection on power dynamics in international policies and governance

Deliverables

- A detailed outline of the study
- A fully referenced manuscript ready for publication in line with FES style guide
- Executive Summary highlighting key message and findings
- Two rounds of peer review
- Engagement in review processes and incorporation of feedback
- Participation in presentation of findings and outcome dissemination
